Results of the 2016 Renewal Audit

On February 11, 2016, the Board conducted its annual audit of 2016 renewal applications. Board members randomly selected and audited 236 renewal applications. Approximately 50 of those applications were identified as not having sufficient verification of attendance of continuing education. Donna will contact those individuals to correct the problems and obtain verification. In addition to verification of attendance, the Board conducted an internal financial audit of those 236 applications by tracing the payments to Quick Books and to the credit union deposit slips. No problems were noted in the financial transactions.

Administrative Assistant Annual Performance Review

The Board conducted the annual performance review of Administrative Assistant Donna Coffey. The Board noted that Donna exceeds expectations and noted specifically the work she has done with the Legislative Review Committee. The Board approved paying Donna a bonus of \$1,000.
