#### Internal Audit Committee Report – Patricia Hawkins, Chair

The Internal Audit Committee completed an internal audit of the Board's financial records earlier in the day. The Committee reviewed records dated between October 11, 2012 and January 30, 2013. No irregularities were found. In accordance with external auditor recommendations, the Committee also performed random audits/cross checks between actual deposits and RSTAS to ensure no irregularities.

#### Renewal Audit Committee Report – Patricia Hawkins, Chair

Patricia Hawkins made a preliminary report on the Renewal Audit. Nine Board Members assisted in the Renewal Audit of approximately 250 renewal applications. Initial problems were discovered in 7 of those renewals. Patricia will work with applicants to correct the problems where possible. She will report the results at a future meeting.

The Board discussed how to best ensure that all registrants have taken the required public health law course within the required timeframe of 4 years from their original date of registration. Board Action: Debra Yarbrough made a motion to direct the Administrative Assistant to audit, prior to the March 21, 2013 board meeting, all of those registered in 2008 to ensure that they have taken the mandated public health law course. Patricia Hawkins seconded the motion. All votes affirmative.
