The Board must report to OAH no later than November 15 with OAH reviewing submitted materials in mid-December. Following additional discussion regarding existing Board Rules and in light of the fact

that no public comments were received, the Board classified all rules as necessary without substantial public interest and appointed Seth Swift as the Board's Rule Making Coordinator.

Board Action: <u>Larry Michael made a motion to classify all rules as necessary without substantial public interest</u>. <u>Phil Thompson seconded the motion</u>. <u>All votes affirmative</u>

Board Action: Phil Thompson made a motion to appoint Seth Swift as the Board's Rule Making Coordinator. Ann Absher seconded the motion. All votes affirmative.

Greg Bright agreed to forward a letter to the Office of Administrative Hearings confirming the Board's action appointing Seth.

Board Action: Larry Michael made a motion to go into closed session to discuss a confidential ongoing investigation. Patricia Hawkins seconded the motion. All votes affirmative.

At 11:16 a.m., the Board moved into closed session to discuss an confidential investigative matter.

At 11:30 a.m., the Board resumed to open session.

## Multi-purpose Application Form - Patricia Hawkins

The Board discussed the most recent version of the proposed Multi-Purpose Application Form and associated fees. Board members agreed that additional work, in collaboration with attorney John Barkley, should be done regarding the form and types of application fees. Greg agreed to invite Mr. Barkley to the upcoming December meeting.

### **NEHA Exam Scoring Change**

Patricia Hawkins reported that NEHA recently transitioned to a new scoring model. The new model conflicts with 21 NCAC 62.0403 (c) that outlines specifically how the Board must figure individual portions and overall score of the exam. The Executive Committee and Patricia had a telephone meeting with NEHA staff members in August to determine how to dovetail the new NEHA scale with the needs of the Board. NEHA agreed to furnish documentation that will bridge the old and new scoring models until the Board is able to update its Rules. Board members agreed there is further work to do, in collaboration with Attorney John Barkley, to update Rule 21 NCAC 62.0403 (c).

### **Software Update**

Donna Coffey reported to the Board that the version of QuickBooks currently in use is a 2009 version and should be updated.
