#### **Legislative Committee Report – Larry Michael**

Larry Michael reported that DHHS continues to review environmental health related Rules as part of regular 5year Rule Review process. In addition, the legislative report to possibly move regulation of private wells from DHHS to DEQ continues to be reviewed. The General Assembly will convene its 2018 short session on May 16.

Phil Thompson reported that he continues to attend Joint Legislative Committee meetings related to Occupational Licensing Boards. The Committee plans to present new oversight regulations during the 2018 General Assembly short session.

#### **Preliminary Thoughts**

Considering all the unknowns at this point, the best approach would be:

- Donna continue to work with NEHA to finalize the new contract (no later than August 1, 2018) and the process for interns to apply to take the NEHA exam online;
- Offer paper exams at least through July 2018 (or October 2018 if the board so chooses);
- Notify counties now, since they are in the middle of budget planning, that starting August 1, 2018:
  - NEHA is increasing the cost of exams to the amounts stated in the chart above;
  - Between now and August 1, 2018, the Board will also transition to online NEHA exams
  - Interns will still be required to take the essay/interview portions of the exam in person at times and places determined by the Board.
