Education Committee Recommendation: Approve full NC REHS status for individuals as presented.

Board Action. Greg Caulder made a motion to accept the Education Committee Report as presented. No second needed as this was a Committee Report. Daniel Ortiz recused himself from voting on individuals employed by Mecklenburg County. All votes affirmative.

It was noted that with Jessica Silver who served on the Education Committee has transitioned off the Board effective December 15, 2019 with the expiration of her second term on the Board. Jessica served on the Education Committee, and now there is a vacancy on the Education Committee.

Board Action. Chair Daniel Ortiz appointed Rebecca Rosso to the Education Committee and fill the vacancy. The 2020 Education Committee consists of Melanie Campen (Committee Chair). Andrew Morgan. Felissa Vazguez and Rebecca Rosso.

Legislative Update – Larry Michael

Larry updated the Board on recent legislative action and noted that the State is currently operating without a General Assembly approved budget.

Board Assistant Annual Performance Review

Board members discussed Donna Coffey's work performance over the last year. Chair Daniel Ortiz announced that in consideration for outstanding work performance in 2019, the Board will award Donna Coffey a one-time lump sum bonus of \$2,000, net of taxes, payable on 2/14/2020.

Board Action: Andrew Morgan made a motion to pay Donna Coffey a one-time lump sum bonus of \$2.000. net of taxes. payable on 2/14/2020. Phil Thompson seconded the motion. All votes affirmative.

2020 Renewal Audit

The Board conducted its annual audit of 2020 NC REHS renewal applications. Board members randomly selected and audited 112 renewal applications (10% of active registrants excluding interns hired after 10/1//2019). Audited renewal applications were cross referenced to verify attendance via sign in rosters and certificates. 99% of the renewals had sufficient verification of attendance of continuing education. Donna Coffey will work with individual REHS to obtain sufficient verification of attendance. In addition to verification of attendance, the Board conducted an internal financial audit of those 112 applications by tracing the payments to Quick Books, RSTAS and to the credit union deposit slips. No problems were noted in the financial transactions.

Chair Daniel Ortiz asked the Board's opinion on the possibility of outsourcing future annual renewal audits. Different ideas discussed by the Board included seeking assistance from retired NCREHS and former Board members. Discussion also included how to compensate the volunteers to include a stipend and mileage. The Board directed Board Assistant, Donna Coffey, to explore options for conducting future renewal audits and report back to the board at a future meeting.

Board Action. Carl Kivett made a motion to direct Donna Coffey to explore options for conducting future renewal audits and report back to the Board at a future meeting. Greg Caulder seconded the motion. All

votes affirmative.
